# Child Trafficking Information and Advice Line (CTAIL)

- **Launched 2007**
- **Free phone service staffed by social workers giving support and advice**
- **Case consultation to individuals and groups**
- **Referral to specialist help**
- **Advocacy**

# Co-Ordinators of Practice Learning and Assessment (CoPLA)

- **Co-ordinates NSPCC and external placements with relevant agencies**
- **Recruit, supports and negotiate Assessors and Mentors for NSPCC**
- **Provide a link between NSPCC, Universities and training providers.**
- **Develop specialist teaching modules for Social Work and other discipline training**



# Child Exploitation and Online Protection Service

- In partnership with Fresh Start
- Identify, locate and protect children from sexual exploitation and on line abuse
- Engage and empower children through information and education
- Provide information and support to professionals, families, business and the community
- Bring offenders to justice and deter offending
- Develop safe online environment

# STOP IT NOW

- In partnership with NSPCC Fresh Start since Sept 2007
- London management of national education programme
- Campaign through leaflets, posters and multi media, targets:-
  - Adults concerned that they might abuse
  - Family and friends concerned about an adult's sexual behaviour towards children
  - Adults concerned about a young person's sexual behaviour
